That subdivision requires WETA to establish a public input process for taking public comment on the plans and requires WETA to hold at least one public hearing at least 60 days prior to the adoption of the plans in each city where an operational ferry facility existed as of January 1, 2008.

If less than a quorum is present at a public hearing, the public hearing will be conducted as a workshop.
